INSTRUCTIONS FOR RELOCATION WARREN and FOREST COUNTIES

If you intend to relocate (move) with the child/children in a manner which significantly impairs the ability of a non-relocating party to exercise his/her custodial rights, follow the instructions below. You may also wish to consult with an attorney.

- Complete the Notice of Proposed Relocation. All information must be provided except where the information is confidential pursuant to 23 Pa.C.S. § 5336(b) or (c). If you do not have the information requested, you must obtain that information and include it in the Relocation Notice before proceeding.
- After completing the Relocation Notice, make a photocopy for each adult party in the case. Be sure to keep a copy for yourself. Attach a blank "Counter-Affidavit" to each copy of the Relocation Notice and mail a copy of all four pages to each adult party in the case by certified mail, return receipt requested, restricted delivery at least 16 days before the date of your proposed relocation or other time as set forth in 23 Pa.C.S. § 5337(c)(2).
- The Post Office should return to you a "Green Card" indicating the date that each party received his/her copy of the Relocation Notice. Retain the "Green Card" as you may need it later.
- After 30 days have past, or upon receipt of Counter-Affidavits from all nonrelocating parties, whichever occurs sooner, complete one of the following:
 - If all non-relocating parties have not objected to the relocation, then file the following documents with the Prothonotary's Office in the courthouse:
 - 1. a Petition to Confirm Relocation;
 - 2. a copy of the Notice of Proposed Relocation;
 - 3. all "Green Cards" and Counter-Affidavits received from non-relocating parties; and
 - 4. a proposed order including the information set forth at 23 Pa.C.S. § 5337(c)(3).
 - 5. If no custody case exists, you also need to file a **Complaint For Custody**.
 - If you have received an objection to the proposed relocation, then file all of the following documents with the Prothonotary's Office in the courthouse:
 - 1. a **Complaint For Custody** (new case) or **Petition For Modification** (existing case), as applicable;
 - 2. a copy of the Notice of Proposed Relocation;
 - 3. a copy of the Counter-Affidavit indicating objection to the relocation; and
 - 4. a **Request For Hearing**.
- The Court will schedule an expedited hearing, or enter a new Custody Order as it deems appropriate.
