Tax and Prothonotary fees must be paid before cases will be entered.

Judgments will not be entered in any action until the fees of the Prothonotary are paid.

Papers will not be accepted for filing or entry by the Prothonotary unless properly endorsed.

Compensation for Witness: \$5 per day plus mileage.
Compensation for Jurors: \$9 per day plus mileage.
